Dear NASCAR, Civil Air Terminal User:

The Delaware River & Bay Authority welcomes your planned arrival for the upcoming NASCAR race events scheduled **April 26th through April 28th** at the Dover International Speedway. The Dover Air Force Base (KDOV) requires the issuance of a Prior Permission Control Number (PPR), and compliance with **Mandatory Enhanced Security Procedures (MESP)** prior to your arrival. Adherence to the MESP in addition to guidelines established by the Transportation Security Administration will ensure the safety of your passengers in Dover. Please visit the Civil Air Terminal's website at <u>www.catatdover.com</u> to obtain arrival documents for the issuance of a PPR, and any updated information regarding use of Dover AFB.

There is an assessed airport landing fee based on the FAA Aircraft Design Group that will be collected by the FBO. Aircraft Design groups and pricing are shown below. Atlantic Aviation, ILG will be the ground-handler, please contact them regarding services pricing at (302) 328-9695 or by email at <u>ILGfrontdesk@atlanticaviation.com</u>. As a reminder, the Authority's general aviation airport; Delaware Airpark (33N) is available as a public-use alternative with no prior permission requirements. DOVER AIR FORCE BASE (DOV) SPECIAL ARRIVAL NOTES

- Please check NOTAMs for DOV regarding current airfield conditions.
- Access to the Civil Air Terminal is by local roads only and <u>cannot</u> be reached via the Air Force base entrances.
- Directions to the Civil Air Terminal can be found at this link: Civil Air Terminal Directions
- Dover Air Force base requires all helicopter operators to obtain a PPR prior to use of the Civil Air Terminal. <u>FOR EVERYONES SAFETY</u>, helicopter operators must coordinate all arrival and departure operations prior to operating at the Terminal. Non-compliance will result in loss of use of the Dover Civil Air Terminal
- Atlantic Aviation can be contacted via Unicom frequency 122.950 for parking instructions.

DOVER AIR FORCE BASE (DOV) MANDATORY ENHANCED SECURITY PROCEDURES

To ensure a practical level of security at the Dover Civil Air Terminal and associated facilities located on the Dover Air Force base, the Air Force requires all civilian aircraft comply with the following Mandatory Enhanced Security Procedures (MESP). Failure to comply with the established MESP procedures may result in denial to land at the Dover Air Force base.

□ Mandatory 72-hour Prior Permission Required (PPR) – Aircraft will be issued a PPR control number for landing approval by calling (302) 571-6312 Aircraft will not be permitted to land without a PPR. Change in arrival information must be reported to Dover Civil Air Terminal staff prior to departure for Dover Air Force base.

□ Provide a Passenger/Crew Manifest upon request of Air Force or Dover Civil Air Terminal personnel

- Pilots must perform a comprehensive aircraft security check prior to departure for Dover Air Force base to ensure that no weapons, explosives, or other hazardous materials (Biological/Chemical/ Nuclear) are on board.
- □ <u>The Pilot-in-Command of aircraft using the Dover Civil Air Terminal is responsible for positively</u> <u>identifying passengers and baggage, prior to arrival and departure from Dover Air Force base.</u>

"Exhibit A"

- 3) The User will pay or settle every claim for death or injury to United States personnel, or for loss or damage to property of or under the control of the United States or United States personnel, arising out of the use of the military airfield or military supplies or services, by the User, unless the death, injury, loss, or damage results solely from the negligence or willful misconduct of United States personnel.
